Application Process

*Supporting Documents

- A mailed FPL bill in the name of an adult member of the household
- State of Florida Picture Identification showing Broward County address (for all persons over 18)
- Proof of immigration status (permanent residence) for all non-US citizens
- Social Security Cards for all household members
- Birth certificates for all children 5 years of age or younger
- Proof of income (see following column)
- Current rental lease or mortgage statement
- Current Section 8 or Public Housing Contract, and Form 50059 showing current utility allowance

Additional documents may be requested upon review of your application.



Proof of Income

Provide Proof of Income for ALL household members

- Pay stubs for last 3 months of employment
- Company letterhead verifying start date, pay rate, frequency of pay, and average hours worked per week
- Unemployment Wage Determination Statement
- Unemployment check stubs for last 3 months
- Current Social Security, Disability, and/or SSI Benefit Statement
- Current Pension Statement
- Current Veterans' Benefits
- Current Workers' Compensation Benefits
- Current Retirement Benefit Statement
- Current Food Stamp and AFDC Verification printout
- Current Child Support Verification
- Notarized letters from persons who assist the household financially, indicating how much and how often
- Notarized attestation forms (included with the application package) for adults 18 and over who have no income
